experience military way of life for a period of four years, Indian Air Force invites ONLINE applications from unmarried Indian male and female
candidates for selection test from 25 September 2025 onwards to join the IAF as an AGNIVEERVAYU. The number and employability of female

- Application is required to be filled only ONLINE by the candidates and detailed instructions to fill up the same are available at https://agnipathvayu.cdac.in.
- This examination is valid for AGNIVEERVAYU INTAKE 02/2026.
- ONLINE REGISTRATION shall commence at 1100 Hr on 11 July 2025 and will close at 2300 Hr on 31 July 2025. Only ONLINE REGISTERED applications shall be accepted. For registration log on to https://agnipathvayu.cdac.in.
- Note. Candidates are advised to register at the earliest opportunity as no extension of registration dates will be accommodated.

ELIGIBILITY CRITERIA

- 5. Age.
 - 5.1. Date of Birth Block. Candidates born between 02 July 2005 and 02 January 2009 (both dates inclusive) are eligible to apply.
 - In case, a candidate clears all the stages of the Selection Procedure, then the upper age limit as on date of enrolment should
- 6. Marital Status and Pregnancy. Only unmarried candidates (male & female) will be eligible for enrolment as Agniveervayu and they shall undertake not to marry during the defined engagement period of four years. Keeping in view limited period of engagement of Agniveervayu inclusive of training, skill development activities, practical as well as formative assessment and organisational requirement of continued service of fraining, skill development period undertaken period. In organisational engagement period will adversely affect the operational efficiency of the Indian Ari Force. Agniveervayu during the said period shall be discharged from the service. Further, only unmarried Agniveervayu will be eligible for Selection in regular cadre as Airman. Female candidates additionally shall be regulared to undertaken or to get pregnand during the engagement period of four years. Such female Agniveervayu on becoming Low Medical Category (LMC) due to pregnancy shall liable to be discharged from service. Pregnancy will behalf the female Agniveervayu for selection into Regular Cadre. At the time of enrolment, candidates shall require to sign a voluntary undertaking accepting above conditions.
- - 7.1. Science Subjects. Candidates should have passed Intermediate/ 10+2/ Equivalent examination with Mathematics, Pr and English from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

7.2. Other than Science Subjects. Passed Intermediate / 10+2 / Equivalent Examination in any stream/ subjects from Education Boards recognised by Central, State and UT with minimum 50% marks in aggregate and 50% marks in English.

- Note 2. Education Boards recognised by Central, State and UT as on date of registration shall only be considered
- Note 3. Exact aggregate percentage of marks before decimal as written in the marks sheet of 10+2/ Intermediate/ Equivalent Examination/

- 8. **Domicile Category.** Candidates have to choose one of the domicile categories mentioned below and declare the same as their domicile State/ UT in the domicile column in the online application form at the time of orline registration. They are also required to upload the relevant Domicile Certificate/ COAFP Certificate as per the category chosen. The following are the categories of domicile:-Domicile Category. Candidates have to choose
 - Permanent Domicile. Permanent Domicile of the districts of State (s)/ UTs. The candidate shall produce 'Domicile Certificate' issued by any Gazetted Officer in Revenue Department or any other official authorised by the State Government of the particular State/ UT.
 - 8.2. COAFP.I. Children of serving Air Force personnel [Officers/ Airmen/ NCs(E) and Unit Cadre Civilians paid from Defence Estimates] whose father/ mother is presently serving in any Air Force Unit/ any other Organisation located in the districts of State (s)/ UTs, Such candidates will produce latest COAFP (Children of Air Force Personnel) Certificate.
 - 8.3. COAFP-II. Children of Air Force personnel [Officers/ Airment/ NCs (E) and Unit Cadre Civilians paid from Defence Estimates] whose father/ mother is Retired/ Discharged/ Deceased and they are residing in the districts of State (s)/ UTs. Such candidates will produce a proof of minimum stay of one year along with original and photocopy of Service Book/ Discharge Book/ Casualty Service Certificate/ Service Particular Certificate (issued from DPC-3/ POAV as applicable) in case of Officers/ Airmen/ NCs (E) and a Certificate duly signed by OIC Civil Admin and counter signed by CO/ C Adm O of the last served unit, in case of Civilians.

Note. Domicile Category once chosen will not be changed later as the same will be applicable to the candidate at the time of shortlisting for Phase-II exam and preparation of Provisional Select List (PSL) which will be done state-wise as per the vacancies allocated for each state /UT. As per the category chosen during registration, candidate will be required to produce relevant original Domicile Certificate/ COAFP Certificate (if shortlisted for Phase-II Exam) for every stage of selection till enrolment.

- 9. Mandatory Medical Standards. General Medical Standards for AGNIVEERVAYU male & female candidates are as follows:-
 - - 9.1.1. For Male Candidates. Minimum acceptable height is 152 cms.
 - For Female Candidates. Minimum acceptable height is 152 cms, For candidates belonging to North East or hilly regions of Uttarakhand, a lower minimum height of 147 cms will be accepted. In case of candidates from Lakshadweep, the minimum height will be 150 cms.
 - lote. Female candidates availing height relaxation for being domicile of North East/ hilly regions of Uttarakhand/ Lakshadweep re to submit domicile certificate with endorsement of domicile stalus at the time of Phase-II testing. Further, female candidates om hilly region at their of Uttarakhand usust have specific endorsement of hilly region in their domicile certificate.
 - Weight. Weight should be proportionate to height and age as applicable for IAF.

- - 9.3.1. For Male Candidates. The chest wall should be well proportioned and well developed. Minimum circumference should be 77 cms and the chest expansion should be atleast 05 cms.
 - 9.3.2. For Female Candidates. The chest wall should be well proportioned and should be with minimum range of expansion of 05 cms.
- Hearing. Candidate should have normal hearing i.e. able to hear forced whisper from a distance of 6 meters by each
- Dental. Should have healthy gums, good set of teeth and minimum 14 dental points
- 9.6. General Health. Candidate should be fit for the Air Force, must conform to the medical standards and should be of normal anatomy without loss or deformity of any appendages. He' She should be free from any active or latent, acute or chronic, medical or surgical disability or communicable disease, infection and skin ailments. Candidate shall be physically and mentally FIT to perform duty in any part of the world, in any climate and terrain.
- Gynaecological Examination (For female candidates). The examination covers external genitalia, hernia orifices and the perineum, any evidence of stress urinary incontinence or genital prolapse outside introitus.
- 9.8. Gender. Any candidate if found to have predominant characteristics of the opposite gender as evident on external physical examination, will be rejected as Unfit. Any candidate having undergone gender reassignment surgery will be declared Unfit.
- Pregnancy (For female candidates). Any candidate, if found pregnant shall be disqualified and her candidature will be rejected.

- 9.10.1. Candidates should bring latest prescription (not older than one month) and spectacles for corrected vision, if used. The prescription must bear the dioptre measurement, name, signature, stamp and registration number of Ophthalmologist. Date of prescription should be within a month prior to appearing for medical examination.

- 10. Consumption of Narcotic Drugs and Psychotropic Substance (NDPS). On completion of four years of service, based on organisation's requirements and policies promulgated by the Indian Air Force, Agniveervayu will be offered an opportunity to apply for enrolment in the regular cadre of the Indian Air Force as Airmen. These applications will be considered in a centralised manner based on objective orderia, including performance during their four-year engagement period and up 25% of each specific batch of Agniveervayu will be the remoted in regular cadre of Indian Air Force. Agniveervayu will not have any right to be selected for further enrolment into the Indian Air Force. - Employability. Agniveervayu enrolled under this entry are liable to be assigned any duty in organisational interest at the discretion of the
- 16. Training. On being enrolled, Agniveervayu will be imparted military training based on Indian Air Force requirements.
- Leave. Grant of leave will be subject to exigencies of the Indian Air Force. The following leave is applicable for Agniveervayu during their engagement period :-
 - 17.1. Annual Leave, 30 days per year.
 - 17.2. Sick Leave. Based on medical advice by competent Medical Authority.
- Medical and CSD Facilities. For the duration of their engagement period in the Indian Air Force, Agniveeryayu will be entitled for medical facility at service hospitals as well as CSD provisions.
- 19. Pay, Allowances and Allied Benefits. Agniveervayu enrolled under this Scheme will be paid an Agniveer package of ₹30,000- per morth with a fixed yearly increment. In addition, Risk and Hardship allowances (as applicable in Indian Air Force), Dress and Travel allowances will be paid. Perks such as ration, dofting, accommodation and Leave Travel Concession. (ICT) shall also be provided as per the existing rules.
- 20. Terminal Benefits Seva Nidhi Package. Agniveervayu will be given one time 'Seva Nidhi' package comprising of their monthly contribution along with matching contribution by the Government on completion of their engagement period, as indicated below:

- Note 1. Agniveervayu will not be required to contribute to any Provident Fund in Indian Air Force.
- Note 2. There shall be no entitlement to gratuity and any kind of pensionary benefits.

- Insurance, Death and Disability Compensation. Agriveervayu will be provided non-contributory Life Insurance cover of ₹ 48 Lakhs for the of their engagement period as Agriveervayu uit the Indian Air Force. Agriveervayu will not be governed by provisions contained in the Pension riss Rules for Indian Air Force. For details of Death Disability compensation log on to https://agnipathvayu.cdac.in.
- 22. Agniveer Skill Certificate. At the end of engagement period, a detailed Skill-Set certificate will be provided to the Agniveervayu, highlighting the skills and level of competency acquired by the personnel during their engagement period.
- 23. Not Entitled to the ESM Status. Agriveen/ayu enrolled under this Scheme will not be eligible for Ex-Servicemen status after their discharge from the Service on completion of four years engagement period.
- 24. Agniveervayu will be permitted to appear for NDA/ AFCAT examinations (maximum three attempts) during their engagement period of four years provided they satisfy certain conditions for obtaining permission to do so. Agniveervayu, who have applied for any such examination prior to their enrolment in IAF may be permitted to appear in the same.
- 25. Release at own request prior to completion of engagement period will not be permissible for Agniveervayu. However, in exceptional cases, personnel enrolled as Agniveervayu may be released, with approval of the Competent Authority.

- 26. Online Test. Eligible candidates will be sent admit cards for Phase I of testing on their registered e-mail IDs between 48-72 Hr prior to the examination, Candidates are required to download the admit card, take a colour printout and carry the same to the examination centre. Name of city & exam date will be infirmated to the candidates at an earlier date to enable them to plan their movement. This provisional admit card can also be downloaded by the candidate under candidates login on CASB web portal https://agnipathvayu.cdac.in. All candidates in possession of provisional admit card will undertake Online test will be objective type accession will be admitted as per their admit card. Online test will be objective type accessions will be bildinguid (English & Hindi) except for English paper. Candidates are to bring one blue/ black pen and original AADHAAR card along with them for Phase I testing. Details of the test are as follows:
 - Science Subjects. Total duration of the online test shall be 60 minutes and shall comprise of Physics, Mathematics and English as
 - Other than Science Subjects. Total duration of the online test shall be 45 minutes and shall comprise of English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).
 - 26.3. Science Subjects & Other than Science Subjects. Total duration of the online test shall be 85 minutes and shall comprise of Physics, Mathematics and English as per 10+2 CBSE syllabus and Reasoning & General Awareness (RAGA).
 - 26.4. Marking pattern for online test :-
 - 26.4.1. One mark for every correct answer.
 - 26.4.2. Nil (0) marks for unattempted question.
 - 0.25 marks shall be deducted for each wrong answer. 26.4.3.

Note. Above examination methodology has been designed to facilitate selection process based on qualifications of candidates. Irrespective of the examination methodology Agriveervayu enrolled under this entry are liable to be assigned any duty in organisational interest, at the discretion of the Indian Air Force

- 27. Marks scored by the candidates in STAR Phase-I Testing will be "Normalised" by using the formula as published on the web site https://agnipathveyu.cdacin. to take into account variation in difficulty levels of the question papers across different sessions. Candidates are to note that the application of Cut-Off for shortlisting of candidates for STAR Phase-II testing and preparation of Final Merit List for selection will be based on "Normalised Marks" and not in the "Actual Marks" scored by the candidate in STAR Phase-I testing, "Uniter, on normalisation, marks scored by a candidate in a subject may become less/ more than actual marks, and more than total marks of that subject in exceptional cases. Shortlisting for Phase-II testing will be carried out in state-wise manner. The Cut-Off marks for shortlisting for Phase-II testing may vary from state to state as vacancies have been allocated in a state-wise manner.
- 28. CANDIDATES ARE TO QUALIFY IN EACH PAPER INDIVIDUALLY IN SCIENCE SUBJECTS AND OTHER THAN SCIENCE SUBJECTS, with normalised marks. The result of Phase-I and state-wise shortlisting for Phase-II, based on their performance in Phase-I online test, will be uploaded in candidate's individual log in ID on https://agnipathvayu.cdac.in.
- 29. In the event of extraneous circumstances resulting in non-conduct of STAR online test for Intake 01/2027, Indian Air Force reserves the right to shortlist candidates for Phase-II for Intake 01/2027 based on the marks obtained for STAR 02/2026, subject to the candidate meeting upper age limit as on date of endment.

- 30. Soon after the declaration of the result of Phase-I (Online) Test, a cut off will be applied on the normalised marks scored by the candidates in the Phase-I Test and state-wise SHORTILSTED candidates will be sent a new Admit Card on their registered e-mail IDs for Phase-I test at a designated ASC as per their domicile category chosen at the time of registration (refer para 8). This Admit Card for Phase-II exam can also be downloaded online under candidates login on CASB web portal https://agnipathvayu.cdac.in. Candidates have to report on the stipulated date and time for Phase-II at the designated ASC along with following:

- 30.10. Original Phase-I Admit Card used during Phase-I test bearing Air Force seal and invigilator's signature.
- 30.11. Body tattoo photographs as per Para 11 above.
- 30.12. Original and four self-attested photocopies of NCC 'A', 'B' or 'C' certificate (if applicable).
- 30.13. Copy of permission letter obtained from unit/ station (Applicable only for serving Agv NC).
- Note-1. Original NCC certificate must have serial No., round seal of issuing authority and stamp of signing authority. Photo affixed on the certificate must have been attested by issuing authority with stamp.
- Note-2. Candidates discharged from Indian Army/ Indian Navy/ any other Government Organisation shall also be eligible subject to their discharge with NO ADVERSE ENTRIES. Such candidate has to declare at the time of testing for Phase-II that he/ she is an Ex-employee of above askid organisations and produce original Discharge Certificate. - 32. Verification of eligibility.
